Meeting Minutes

Call to Order

- S. Andola called the meeting to order at 6:35 pm.

Establishing Quorum

- D. Bégin, established quorum at 6:35 pm.

Approval of Minutes

- D. Bégin presented the meeting minutes from the last meeting dated March 7th, 2023, with small adjustments for clarity.
- The motion to approve the minutes moved by D. Bégin and seconded by S. Charbonneau.

- Skills and Drills programming was well received. Operations received positive feedback regarding the Coach that led the most recent session. The Coach expressed interest in running some summer beach drills sessions.
- S. Villeneuve has been confirmed as our Summer League Coordinator.
- Operations continues to work diligently to secure beach courts for summer programming.
- Additional courts will most likely be located at Mooney's Bay Beach.
- Summer League programming will open to 15 teams. Once courts are confirmed at Mooney's Bay Beach, additional spaces will be opened.
- The GOV summer tournament will be on August 19th. A lead for the tournament has not been determined yet.

Update on Volunteer Recruitment and Recognition

- Volunteer Appreciation Week is April 16-22, 2023.
 - o GOV will highlight a variety of volunteers and their work.
 - o D. Dewar is working with M. Mumby on the End of Year Soirée.
 - o D. Dewar is developing role descriptions and onboarding material.
 - The Administration Department is also looking to form a database of volunteers and specialized candidates for the permanent roles.
 - A new page on the website will be added that focuses on casual volunteer recruitment. It will feature a short application.
 - o GOV is planning to offer naloxone training in the coming months.
